- The balance of the FY 2010 unearned fee of \$2,839,110 shall be applied to the following prioritized list of unfunded site support projects. The Contractor may allocate the unearned fee between these projects as needed in order to ensure successful completion.

* Approximately 58% (\$289k/\$500k) of the estimated project cost is funded, replacement of all fixtures for the site will require additional funding.

- The Contractor shall segregate all costs for these projects and provide quarterly cost performance and activity reports not later than 15 days after the end of each quarter through the end of the fiscal year. The Contractor shall apply any remaining unearned fee balances in accordance with direction from the Contracting Officer.
- Once determined by DOE/NSNA, draw-down of the FY 2011 unearned fee from the payments cleared financial arrangement and the 211009 liability account is not authorized without written approval by the Contracting Officer. In addition, the Contractor shall not plan for the use any unearned fee in the establishment indirect cost budgets or rates other than as directed by the Contracting Officer.
