The purpose of the Modification is to incorporate the NNSA Fee Determination Official's Performance Incentive Fee and Award Term Determination for FY 2013. The Total Performance Incentive Fee earned is \$21,489,470. The Contractor is authorized to draw down from the payments cleared financial arrangement the amount of \$11,543,060, the difference between the earned incentive fee of \$21,489,470 and the not-to-exceed provisional incentive fee payment of \$9,946,410. The Contractor failed to earn the Award Term for the performance period and Clauses F-2 and H-14 are hereby modified accordingly, reducing the maximum term of the Contract by one year. Clause B-2 remains unchanged. Except as provided herein, all terms and conditions of the document referenced in Item 9A or 10A, as heretofore changed, remains unchanged and in full force and effect.
